







Governor Newsom Signs Bill to Strengthen California's Mixed-delivery Early Learning and Care System

SB 1047 Will Simplify Preschool and Child Care Enrollment Processes for Families and Provider

SACRAMENTO, CA - On Friday, September 30th, **Governor Gavin Newsom** signed Senate Bill (SB) 1047 into law. Bill author **Senator Monique Limón** and sponsors **Early Edge California**, **Kidango**, and **EveryChild California** celebrate the signing of this monumental legislation which will make it easier for families to enroll in and retain access to subsidized child care and preschool; it will also help providers streamline the enrollment process.

SB 1047 will enable low-income families to more easily enroll in subsidized child care and preschool by using their eligibility for other government subsidized programs, such as CalFresh, Medi-Cal, WIC, or Head Start. This will significantly reduce the paperwork and administrative burden on families and providers. It will also guarantee families' access to subsidized child care and preschool by extending service from 12 to 24 months, relieving families of the worry of losing access to child care programs during crucial developmental years.

"Early childhood education is critical in our children's development, that is why I am grateful that Governor Newsom has signed SB 1047 to expand the enrollment of child care programs throughout the state. SB 1047 will help children and families easily enroll and stay enrolled in high quality early childhood education programs to provide

California children with more continuity of care, setting them up for a successful future," said SB 1047's author Senator Monique Limón (D-Santa Barbara).

"We are grateful that Governor Newsom and Senator Limón continue to support Early Learning and are thrilled that they see the value SB 1047 brings to providers and struggling families. Removing duplicative processes will make enrollment easier for both parents and providers who are still recovering from the impact of the pandemic. Most importantly, it will help children receive consistent and steady learning and care which is so vital to their development during their formative years," said **Patricia Lozano**, **Executive Director of Early Edge California**.

"We want to thank Governor Newsom and Senator Limón for championing low income families with young children by ensuring they do not lose their child's state-funded preschool or child care," said **Scott Moore**, **Kidango's CEO**.
